METHODS OF RESOURCE ALLOCATION

PLANNED ALLOCATION

IN CONTRAST, PLANNED ECONOMIES ALLOCATE RESOURCES BASED ON CENTRALIZED DECISIONS MADE BY THE GOVERNMENT OR A CENTRAL AUTHORITY. THIS METHOD AIMS TO ACHIEVE SPECIFIC SOCIAL OR ECONOMIC GOALS, SUCH AS EQUITABLE DISTRIBUTION OR FULL EMPLOYMENT. HOWEVER, IT MAY LEAD TO INEFFICIENCIES IF THE PLANNERS CANNOT ACCURATELY PREDICT CONSUMER PREFERENCES.

MIXED ALLOCATION

MANY ECONOMIES OPERATE UNDER A MIXED SYSTEM, COMBINING ELEMENTS OF BOTH MARKET AND PLANNED ALLOCATION. IN THIS APPROACH, THE GOVERNMENT MAY REGULATE CERTAIN INDUSTRIES WHILE ALLOWING MARKET FORCES TO DICTATE OTHERS. THIS BALANCE AIMS TO HARNESS THE EFFICIENCY OF MARKETS WHILE ADDRESSING SOCIAL WELFARE CONCERNS.

FACTORS INFLUENCING RESOURCE ALLOCATION
