FREE-RESPONSE QUESTIONS

FREE-RESPONSE QUESTIONS (FRQs) REQUIRE STUDENTS TO WRITE DETAILED ANSWERS THAT DEMONSTRATE THEIR ANALYTICAL AND CRITICAL THINKING SKILLS. THESE QUESTIONS CAN INVOLVE EXPLAINING CONCEPTS, ANALYZING SCENARIOS, OR SOLVING COMPLEX PROBLEMS. FRQs ARE OFTEN DIVIDED INTO TWO PARTS: SHORT-ANSWER QUESTIONS AND LONGER ANALYTICAL ESSAYS.

- **SHORT-ANSWER:** THESE QUESTIONS TYPICALLY REQUIRE CONCISE RESPONSES, OFTEN INVOLVING CALCULATIONS OR DEFINITIONS.
- **ESSAY QUESTIONS:** STUDENTS MUST PROVIDE A COMPREHENSIVE ANALYSIS OF A TOPIC, INTEGRATING MULTIPLE ECONOMIC CONCEPTS.

STRATEGIES FOR ANSWERING AP ECONOMICS TEST QUESTIONS

SAMPLE MULTIPLE-CHOICE QUESTION

WHICH OF THE FOLLOWING WOULD LIKELY CAUSE THE DEMAND CURVE FOR ELECTRIC CARS TO SHIFT TO THE RIGHT?

- A DECREASE IN THE PRICE OF GASOLINE.
- INCREASED CONSUMER INCOME.
- A RISE IN THE PRICE OF ELECTRIC CARS.
- A DECREASE IN THE NUMBER OF ELECTRIC CAR MANUFACTURERS.

THE CORRECT ANSWER IS AN INCREASE IN CONSUMER INCOME, AS HIGHER INCOME GENERALLY LEADS TO AN INCREASE IN DEMAND FOR NORMAL GOODS SUCH AS ELECTRIC CARS.

SAMPLE FREE-RESPONSE QUESTION

DISCUSS THE IMPACT OF A GOVERNMENT-IMPOSED PRICE CEILING ON THE MARKET FOR RENTAL HOUSING. INCLUDE A DIAGRAM IN YOUR ANSWER.

THIS QUESTION REQUIRES STUDENTS TO EXPLAIN THE CONCEPT OF PRICE CEILINGS, THE RESULTING SHORTAGE IN THE MARKET, AND THE POTENTIAL LONG-TERM EFFECTS ON HOUSING AVAILABILITY.
