INTRODUCTION TO AUSTRIAN ECONOMICS

TIME AND UNCERTAINTY

AUSTRIAN ECONOMISTS PLACE SIGNIFICANT IMPORTANCE ON THE CONCEPTS OF TIME AND UNCERTAINTY IN ECONOMIC DECISION-MAKING. THEY ARGUE THAT INDIVIDUALS MAKE CHOICES BASED ON THEIR EXPECTATIONS OF FUTURE EVENTS, WHICH INTRODUCES AN ELEMENT OF UNCERTAINTY INTO EVERY ECONOMIC TRANSACTION. THIS FOCUS ON TIME ALLOWS FOR A DEEPER UNDERSTANDING OF INVESTMENT, INTEREST RATES, AND THE BUSINESS CYCLE.

ROLE OF ENTREPRENEURSHIP
