PROGRAM OVERVIEW

CURRICULUM STRUCTURE

ACADEMIC PREREQUISITES

APPLICANTS TYPICALLY NEED TO HOLD A BACHELOR'S DEGREE IN ECONOMICS OR A RELATED FIELD. WHILE A BACKGROUND IN ECONOMICS IS PREFERRED, STUDENTS FROM DIVERSE ACADEMIC DISCIPLINES MAY ALSO BE CONSIDERED IF THEY MEET OTHER CRITERIA.

STANDARDIZED TESTS

MOST APPLICANTS ARE REQUIRED TO SUBMIT GRE SCORES AS PART OF THEIR APPLICATION. A STRONG PERFORMANCE ON THE

QUANTITATIVE SECTION OF THE GRE IS PARTICULARLY IMPORTANT, AS IT REFLECTS THE ANALYTICAL SKILLS NECESSARY FOR SUCCESS IN THE PROGRAM.

SUPPORTING DOCUMENTS

IN ADDITION TO ACADEMIC TRANSCRIPTS AND STANDARDIZED TEST SCORES, APPLICANTS MUST SUBMIT:

- A STATEMENT OF PURPOSE OUTLINING THEIR ACADEMIC INTERESTS AND CAREER GOALS.
- LETTERS OF RECOMMENDATION FROM INDIVIDUALS FAMILIAR WITH THE APPLICANT'S ACADEMIC OR PROFESSIONAL ABILITIES.
- A RESUME OR CV DETAILING RELEVANT EXPERIENCE AND QUALIFICATIONS.

CAREER OPPORTUNITIES
