- **AMERICAN PSYCHOLOGICAL ASSOCIATION (APA) STYLE:** THIS STYLE IS WIDELY USED IN THE SOCIAL SCIENCES AND EMPHASIZES AUTHOR-DATE CITATIONS. IT IS LESS COMMON IN ECONOMICS BUT MAY BE ENCOUNTERED IN CERTAIN CONTEXTS.
