

CONTRACTIONARY FISCAL POLICY DEFINITION ECONOMICS

WHAT IS CONTRACTIONARY FISCAL POLICY?

CONTRACTIONARY FISCAL POLICY IS A MACROECONOMIC TOOL USED BY GOVERNMENTS TO REDUCE THEIR BUDGET DEFICIT OR CONTROL INFLATION. IT INVOLVES DECREASING GOVERNMENT SPENDING AND/OR INCREASING TAXES. MECHANISMS OF CONTRACTIONARY FISCAL POLICY

IMPLICATIONS OF CONTRACTIONARY FISCAL POLICY

THE UNITED STATES IN THE 1980s
