HE DEMONSTRATED THAT EVEN IF ONE COUNTRY COULD PRODUCE BOTH GOODS MORE EFFICIENTLY THAN THE OTHER, THEY COULD STILL GAIN FROM TRADE BY SPECIALIZING IN THE GOOD FOR WHICH THEY HAD A COMPARATIVE ADVANTAGE.

## LABOR THEORY OF VALUE
