5. DATA ANALYST

WITH THE RISE OF BIG DATA, DATA ANALYSTS SPECIALIZING IN ECONOMICS ARE IN HIGH DEMAND. THESE PROFESSIONALS ANALYZE LARGE DATASETS TO IDENTIFY TRENDS AND PROVIDE INSIGHTS THAT INFORM BUSINESS OR POLICY DECISIONS. PROFICIENCY IN STATISTICAL SOFTWARE AND PROGRAMMING LANGUAGES IS OFTEN REQUIRED.

QUALIFICATIONS AND SKILLS REQUIRED

TOP EMPLOYERS FOR ECONOMISTS IN BOSTON

SEVERAL PROMINENT ORGANIZATIONS IN BOSTON ACTIVELY SEEK ECONOMISTS. THESE EMPLOYERS RANGE FROM GOVERNMENT

AGENCIES TO PRIVATE COMPANIES AND ACADEMIC INSTITUTIONS.

1. GOVERNMENT AGENCIES

TOP UNIVERSITIES LIKE HARVARD, MIT, AND BOSTON UNIVERSITY EMPLOY ECONOMISTS FOR RESEARCH AND TEACHING POSITIONS. THESE ROLES OFTEN REQUIRE ADVANCED DEGREES AND A STRONG PUBLICATION RECORD.

4. NON-PROFIT ORGANIZATIONS

THINK TANKS AND NON-PROFIT ORGANIZATIONS, SUCH AS THE MASSACHUSETTS BUDGET AND POLICY CENTER, HIRE ECONOMISTS TO ANALYZE POLICIES AND PROVIDE RECOMMENDATIONS FOR SOCIAL ISSUES.

5. CONSULTING FIRMS

CONSULTING FIRMS LIKE DELOITTE AND MCKINSEY & COMPANY VALUE ECONOMISTS FOR THEIR ANALYTICAL SKILLS AND ECONOMIC INSIGHTS, OFTEN INVOLVING PROJECT-BASED WORK.

STRATEGIES FOR JOB SEEKERS
