OVERVIEW OF THE ECONOMICS MINOR AT FSU

THE ECONOMICS MINOR AT FLORIDA STATE UNIVERSITY IS DESIGNED TO PROVIDE STUDENTS WITH A FOUNDATIONAL UNDERSTANDING OF ECONOMIC THEORY, PRINCIPLES, AND PRACTICES. THE PROGRAM IS STRUCTURED TO ENSURE THAT STUDENTS NOT ONLY LEARN THEORETICAL ASPECTS OF ECONOMICS BUT ALSO DEVELOP CRITICAL THINKING AND ANALYTICAL SKILLS THAT CAN BE APPLIED IN REAL-WORLD SCENARIOS.

BENEFITS OF AN ECONOMICS MINOR

CORE COURSES REQUIRED FOR THE MINOR
