OVERVIEW OF FLORIDA STATE UNIVERSITY ECONOMICS PHD

IT IS ESSENTIAL FOR APPLICANTS TO DEMONSTRATE THEIR PASSION FOR ECONOMICS AND THEIR POTENTIAL FOR CONDUCTING RESEARCH. THE ADMISSIONS COMMITTEE EVALUATES APPLICATIONS HOLISTICALLY, CONSIDERING ACADEMIC PERFORMANCE, RESEARCH EXPERIENCE, AND FIT WITH THE PROGRAM.

CAREER PROSPECTS
