CURRICULUM AND COURSEWORK

THE CURRICULUM FOR THE FLORIDA STATE UNIVERSITY PhD IN ECONOMICS IS STRUCTURED TO PROVIDE STUDENTS WITH BOTH THEORETICAL KNOWLEDGE AND PRACTICAL SKILLS. ELECTIVES MAY INCLUDE SPECIALIZED TOPICS SUCH AS LABOR ECONOMICS, INTERNATIONAL ECONOMICS, PUBLIC ECONOMICS, AND ENVIRONMENTAL ECONOMICS. THIS TAILORED APPROACH ALLOWS STUDENTS TO DEEPEN THEIR KNOWLEDGE IN SPECIFIC AREAS WHILE ALSO DEVELOPING A BROAD UNDERSTANDING OF ECONOMIC PRINCIPLES.
