INCORPORATING MARKET RESEARCH, PRICING STRATEGIES, AND MARKETING PLANS.

- **Stock Market Simulation:** A VIRTUAL STOCK TRADING GAME WHERE STUDENTS BUY AND SELL STOCKS, LEARNING ABOUT MARKET TRENDS AND INVESTMENT STRATEGIES.

INCORPORATING THESE ACTIVITIES CAN LEAD TO A MORE COMPREHENSIVE UNDERSTANDING OF ECONOMIC PRINCIPLES WHILE MAKING THE LEARNING EXPERIENCE ENJOYABLE AND MEMORABLE FOR STUDENTS.
