ADDITIONALLY, BORJAS HAS EXPLORED THE CONCEPT OF THE "IMMIGRANT WAGE EFFECT," WHICH EXAMINES HOW THE PRESENCE OF IMMIGRANT WORKERS IMPACTS THE WAGES OF NATIVE WORKERS IN OVERLAPPING SECTORS. HIS FINDINGS SUGGEST THAT WHILE IMMIGRATION CAN ENHANCE OVERALL ECONOMIC PRODUCTIVITY, IT MAY ALSO EXACERBATE WAGE INEQUALITY AMONG DIFFERENT WORKER GROUPS.

## WAGE EFFECTS AND EMPLOYMENT

BY UNDERSTANDING THE ECONOMIC IMPLICATIONS OF IMMIGRATION AS PRESENTED IN BORJAS'S RESEARCH, POLICYMAKERS CAN CREATE MORE EFFECTIVE STRATEGIES THAT BALANCE THE BENEFITS OF IMMIGRATION WITH THE PROTECTION OF NATIVE WORKERS' INTERESTS.
