FOR EXAMPLE, IN TIMES OF CRISIS, SUCH AS NATURAL DISASTERS OR PANDEMICS, DEMAND FOR CERTAIN GOODS MAY SURGE, LEADING TO PRICE INCREASES AND POTENTIAL SHORTAGES. CHANGES IN INTEREST RATES CAN INFLUENCE BORROWING AND SPENDING, THEREBY AFFECTING OVERALL ECONOMIC PERFORMANCE. THE INTERPLAY BETWEEN THESE POLICIES AND ECONOMIC OUTCOMES IS VITAL FOR UNDERSTANDING HOW ECONOMICS EXPLAINS THE WORLD FREE.
