EXCHANGE RATES

EXCHANGE RATES ARE CRITICAL IN INTERNATIONAL ECONOMICS, DETERMINING HOW MUCH ONE CURRENCY IS WORTH IN RELATION TO ANOTHER. VARIATIONS IN EXCHANGE RATES CAN SIGNIFICANTLY IMPACT TRADE BALANCES AND INVESTMENT FLOWS.

THE IMF PLAYS A VITAL ROLE IN MAINTAINING STABILITY IN THE INTERNATIONAL MONETARY SYSTEM, ESPECIALLY DURING TIMES OF ECONOMIC CRISIS.

WORLD BANK

THE WORLD BANK IS ANOTHER KEY PLAYER IN INTERNATIONAL ECONOMICS, FOCUSED PRIMARILY ON PROVIDING FINANCIAL AND TECHNICAL ASSISTANCE TO DEVELOPING COUNTRIES. ITS MAIN GOALS INCLUDE:
