BENEFIT-COST RATIO (BCR)

THE BCR COMPARES THE BENEFITS OF A PROJECT TO ITS COSTS. A BCR GREATER THAN ONE INDICATES THAT THE BENEFITS OUTWEIGH THE COSTS, MAKING THE PROJECT POTENTIALLY WORTHWHILE.
