- **INTRODUCTION:** AN INTRODUCTION THAT OUTLINES THE IMPORTANCE OF THE TOPIC AND THE PAPER'S CONTRIBUTIONS.
- **METHODOLOGY:** A SUCCINCT DESCRIPTION OF THE METHODS USED, INCLUDING ANY THEORETICAL FRAMEWORKS OR EMPIRICAL TECHNIQUES.
- **RESULTS:** PRESENTATION OF THE MAIN FINDINGS, OFTEN ACCOMPANIED BY TABLES OR FIGURES FOR CLARITY.
- **DISCUSSION:** A DISCUSSION THAT INTERPRETS THE RESULTS IN THE CONTEXT OF EXISTING LITERATURE AND IMPLICATIONS FOR POLICY.
- **CONCLUSION:** A CONCISE CONCLUSION THAT REITERATES THE MAIN FINDINGS AND SUGGESTS AREAS FOR FUTURE RESEARCH.

CONTENT FOCUS

SHORT PAPERS TYPICALLY FOCUS ON A SPECIFIC RESEARCH QUESTION OR HYPOTHESIS, PROVIDING INSIGHTS THAT CAN LEAD TO FURTHER EXPLORATION. THEY MAY INTRODUCE NEW DATA, CRITIQUE EXISTING METHODOLOGIES, OR PROPOSE NOVEL APPROACHES TO PUBLIC ECONOMIC ISSUES.
