OVERVIEW OF LOUISIANA STATE UNIVERSITY

LOUISIANA STATE UNIVERSITY, LOCATED IN BATON ROUGE, IS ONE OF THE PREMIER INSTITUTIONS IN THE SOUTHERN UNITED STATES. CORE COURSEWORK

STUDENTS ARE REQUIRED TO COMPLETE A SERIES OF CORE COURSES THAT LAY THE GROUNDWORK FOR ADVANCED STUDY. THESE COURSES COVER ESSENTIAL TOPICS SUCH AS MICROECONOMICS, MACROECONOMICS, AND ECONOMETRICS. THE CORE CURRICULUM IS DESIGNED TO ENSURE THAT ALL STUDENTS ACQUIRE A SOLID UNDERSTANDING OF FUNDAMENTAL ECONOMIC PRINCIPLES AND METHODOLOGIES.

ELECTIVE COURSES

IN ADDITION TO CORE COURSES, STUDENTS CAN CHOOSE FROM A VARIETY OF ELECTIVE COURSES THAT ALLOW THEM TO SPECIALIZE IN AREAS OF PARTICULAR INTEREST. THESE EXAMS ARE CRITICAL IN DEMONSTRATING A STUDENT'S READINESS TO UNDERTAKE INDEPENDENT RESEARCH. GENERALLY, STUDENTS TAKE THESE EXAMS AFTER THEIR SECOND YEAR OF STUDY.

DISSERTATION RESEARCH

THE DISSERTATION IS A SIGNIFICANT COMPONENT OF THE PhD PROGRAM, REPRESENTING ORIGINAL RESEARCH THAT CONTRIBUTES TO THE FIELD OF ECONOMICS. STUDENTS WORK CLOSELY WITH FACULTY ADVISORS TO DEVELOP THEIR RESEARCH PROPOSALS AND METHODOLOGIES. THE DISSERTATION PROCESS INCLUDES PROPOSAL DEFENSE, DATA COLLECTION, ANALYSIS, AND FINAL DEFENSE BEFORE A COMMITTEE.

ADMISSION REQUIREMENTS

GAINING ADMISSION TO THE PhD PROGRAM IN ECONOMICS AT LSU REQUIRES MEETING SPECIFIC CRITERIA. THE PROGRAM SEEKS CANDIDATES WHO DEMONSTRATE STRONG ACADEMIC PERFORMANCE, ANALYTICAL SKILLS, AND A PASSION FOR ECONOMIC RESEARCH.

ACADEMIC QUALIFICATIONS

APPLICANTS MUST HOLD A BACHELOR'S DEGREE FROM AN ACCREDITED INSTITUTION, PREFERABLY WITH A STRONG FOUNDATION IN ECONOMICS, MATHEMATICS, AND STATISTICS. A MASTER'S DEGREE IN ECONOMICS OR A RELATED FIELD CAN ENHANCE AN APPLICATION BUT IS NOT MANDATORY.

STANDARDIZED TESTS

LSU REQUIRES GRE SCORES AS PART OF THE APPLICATION PROCESS. COMPETITIVE SCORES, PARTICULARLY IN THE QUANTITATIVE SECTION, CAN SIGNIFICANTLY BOLSTER AN APPLICANT'S CHANCES OF ADMISSION. ADDITIONALLY, NON-NATIVE

ENGLISH SPEAKERS MUST PROVIDE TOEFL OR IELTS SCORES TO DEMONSTRATE PROFICIENCY IN ENGLISH.

LETTERS OF RECOMMENDATION

APPLICANTS MUST SUBMIT AT LEAST THREE LETTERS OF RECOMMENDATION FROM INDIVIDUALS WHO CAN ASSESS THEIR ACADEMIC ABILITIES AND RESEARCH POTENTIAL. STRONG ENDORSEMENTS FROM FACULTY MEMBERS OR PROFESSIONALS IN THE FIELD CAN GREATLY INFLUENCE THE ADMISSIONS DECISION.

PERSONAL STATEMENT

A PERSONAL STATEMENT OUTLINING THE APPLICANT'S RESEARCH INTERESTS, CAREER GOALS, AND REASONS FOR PURSUING A PhD AT LSU IS ALSO REQUIRED. THIS DOCUMENT PROVIDES INSIGHT INTO THE APPLICANT'S MOTIVATIONS AND FIT FOR THE PROGRAM.

RESEARCH OPPORTUNITIES

RESEARCH IS A CORNERSTONE OF THE PhD EXPERIENCE AT LSU, AND STUDENTS ARE ENCOURAGED TO ENGAGE IN VARIOUS RESEARCH PROJECTS THROUGHOUT THEIR STUDIES. THE FACULTY'S DIVERSE EXPERTISE ALLOWS STUDENTS TO COLLABORATE ON INNOVATIVE RESEARCH TOPICS.
