HISTORICAL OVERVIEW OF NATIVE AMERICAN ECONOMIES

WITH THE ARRIVAL OF EUROPEAN SETTLERS, NATIVE AMERICAN ECONOMIES FACED SIGNIFICANT DISRUPTION. THE INTRODUCTION OF TRADE GOODS ALTERED TRADITIONAL ECONOMIC PRACTICES, WHILE COLONIZATION LED TO LAND DISPOSSESSION AND CHANGES IN RESOURCE AVAILABILITY. THE IMPOSITION OF FEDERAL POLICIES, SUCH AS THE DAWES ACT OF 1887, AIMED TO ASSIMILATE NATIVE AMERICANS INTO WESTERN ECONOMIC SYSTEMS, FURTHER COMPLICATING THEIR ECONOMIC LANDSCAPES. AS A RESULT, MANY TRIBES FACED POVERTY AND MARGINALIZATION, STRUGGLING TO MAINTAIN THEIR CULTURAL AND ECONOMIC IDENTITIES.
