NNP CAN BE EXPRESSED USING THE FORMULA:

$$\text{NNP} = \text{GNP} - \text{DEPRECIATION}$$

INCOME APPROACH

Gross National Product (GNP) measures the total economic output produced by the residents of a nation, regardless of where that production occurs. NNP, however, takes into account the depreciation of capital, making it a more refined measure of the actual economic benefits accruing to residents.
