UNDERSTANDING ONLINE PhD HEALTH ECONOMICS

- ECONOMETRICS AND STATISTICAL METHODS
- HEALTH OUTCOMES MEASUREMENT
- COST-EFFECTIVENESS ANALYSIS

THESE COURSES ARE DESIGNED TO BUILD A ROBUST UNDERSTANDING OF HOW ECONOMIC PRINCIPLES CAN BE APPLIED TO HEALTH-RELATED ISSUES.

COMPREHENSIVE EXAMS

FOLLOWING THE COMPLETION OF COURSEWORK, STUDENTS MUST PASS COMPREHENSIVE EXAMS THAT ASSESS THEIR KNOWLEDGE AND READINESS TO UNDERTAKE INDEPENDENT RESEARCH. THESE EXAMS TYPICALLY COVER TOPICS STUDIED DURING THE COURSEWORK PHASE AND MAY REQUIRE STUDENTS TO DEMONSTRATE THEIR ABILITY TO APPLY THEORETICAL CONCEPTS TO PRACTICAL SCENARIOS.

DISSERTATION

THE DISSERTATION IS A CRITICAL COMPONENT OF THE PROGRAM, ALLOWING STUDENTS TO CONDUCT ORIGINAL RESEARCH THAT CONTRIBUTES TO THE FIELD OF HEALTH ECONOMICS. THIS RESEARCH CAN TAKE VARIOUS FORMS, INCLUDING EMPIRICAL STUDIES, THEORETICAL ANALYSES, AND POLICY EVALUATIONS. LETTERS OF RECOMMENDATION

PROSPECTIVE STUDENTS ARE TYPICALLY REQUIRED TO SUBMIT LETTERS OF RECOMMENDATION FROM ACADEMIC OR PROFESSIONAL REFERENCES WHO CAN ATTEST TO THEIR QUALIFICATIONS AND POTENTIAL FOR SUCCESS IN A DOCTORAL PROGRAM.

PERSONAL STATEMENT

A WELL-CRAFTED PERSONAL STATEMENT IS ESSENTIAL FOR APPLICANTS. THIS STATEMENT SHOULD OUTLINE THE APPLICANT'S MOTIVATIONS FOR PURSUING A PhD, RESEARCH INTERESTS, AND CAREER GOALS. IT PROVIDES AN OPPORTUNITY TO DEMONSTRATE PASSION FOR THE FIELD AND ALIGNMENT WITH THE PROGRAM'S OBJECTIVES.
