OVERVIEW OF THE PhD ECONOMICS PROGRAM

PROSPECTIVE STUDENTS SHOULD ENSURE THAT THEIR APPLICATION MATERIALS HIGHLIGHT THEIR STRENGTHS AND ALIGN WITH THE PROGRAM'S OBJECTIVES.

CURRICULUM STRUCTURE

A: THE UNIVERSITY OF PENNSYLVANIA'S STRONG REPUTATION ENHANCES GRADUATES' COMPETITIVENESS IN THE JOB MARKET, MAKING THEM ATTRACTIVE CANDIDATES FOR VARIOUS ACADEMIC AND PROFESSIONAL POSITIONS.
