WHAT IS POLITICAL ECONOMICS?

POLITICAL ECONOMICS IS AN INTERDISCIPLINARY FIELD THAT EXAMINES THE INTERSECTION OF ECONOMICS AND POLITICAL SCIENCE. STRUCTURE OF POLITICAL ECONOMICS PHD PROGRAMS

COURSEWORK

INITIALLY, STUDENTS ENGAGE IN COMPREHENSIVE COURSEWORK THAT COVERS CORE CONCEPTS IN BOTH POLITICAL SCIENCE AND ECONOMICS. THIS COURSEWORK IS DESIGNED TO BUILD A SOLID FOUNDATION IN THE THEORIES AND METHODOLOGIES PERTINENT TO THE FIELD. STUDENTS MAY BE REQUIRED TO TAKE CLASSES IN:

- MICROECONOMICS
- MACROECONOMICS
- POLITICAL THEORY
- QUANTITATIVE METHODS
- PUBLIC POLICY ANALYSIS

COMPREHENSIVE EXAMS

AFTER COMPLETING COURSEWORK, STUDENTS MUST PASS COMPREHENSIVE EXAMS TO DEMONSTRATE THEIR MASTERY OF THE SUBJECT MATTER. THESE EXAMS TYPICALLY COVER BOTH THEORETICAL AND EMPIRICAL ASPECTS OF POLITICAL ECONOMICS AND ASSESS THE STUDENT'S READINESS TO CONDUCT INDEPENDENT RESEARCH.

DISSERTATION RESEARCH

ONCE STUDENTS PASS THEIR COMPREHENSIVE EXAMS, THEY FOCUS ON THEIR DISSERTATION RESEARCH. THIS PHASE IS CRUCIAL, AS IT ALLOWS STUDENTS TO DELVE DEEPLY INTO A SPECIFIC TOPIC WITHIN POLITICAL ECONOMICS, CONTRIBUTING NEW KNOWLEDGE TO THE FIELD. THE DISSERTATION PROCESS INVOLVES SELECTING A RELEVANT RESEARCH QUESTION, CONDUCTING THOROUGH LITERATURE REVIEWS, AND EMPLOYING APPROPRIATE METHODOLOGIES TO ANALYZE DATA.

CORE CURRICULUM IN POLITICAL ECONOMICS PhD PROGRAMS
