OVERVIEW OF PRINCETON'S ECONOMICS PHD PROGRAM

THE PROGRAM'S RIGOROUS ADMISSION STANDARDS ATTRACT SOME OF THE BRIGHTEST MINDS IN THE FIELD, CREATING AN ENVIRONMENT RICH IN TALENT AND INNOVATION.

CURRICULUM AND COURSEWORK

THE CURRICULUM FOR PRINCETON'S ECONOMICS PHD PROGRAM IS STRUCTURED TO PROVIDE STUDENTS WITH A SOLID FOUNDATION IN ECONOMIC THEORY, QUANTITATIVE METHODS, AND EMPIRICAL RESEARCH TECHNIQUES. CORE COURSES

RESEARCH OPPORTUNITIES

THESE CENTERS NOT ONLY PROVIDE FUNDING AND RESOURCES FOR RESEARCH BUT ALSO FACILITATE NETWORKING OPPORTUNITIES WITH LEADING ECONOMISTS AND POLICYMAKERS.

DISSERTATION RESEARCH

AS STUDENTS PROGRESS IN THEIR STUDIES, THEY BEGIN TO DEVELOP THEIR DISSERTATION PROPOSALS. THIS PHASE IS CRITICAL FOR DEFINING THEIR RESEARCH NICHE AND CONTRIBUTING TO THE BODY OF ECONOMIC KNOWLEDGE.
