SCHOLARS ARGUE THAT THE CLARITY AND ENFORCEMENT OF PROPERTY RIGHTS ARE CRUCIAL FOR FOSTERING ECONOMIC GROWTH AND PROMOTING ENTREPRENEURIAL ACTIVITIES.

THE IMPORTANCE OF PROPERTY RIGHTS

- **ENCOURAGING INNOVATION:** PROPERTY RIGHTS PROVIDE INVENTORS AND CREATORS THE ASSURANCE THAT THEY CAN PROTECT THEIR INTELLECTUAL PROPERTY, THUS FOSTERING INNOVATION.

MOREOVER, THE ABSENCE OF RECOGNIZED PROPERTY RIGHTS CAN LEAD TO CONFLICTS AND DISPUTES, UNDERMINING ECONOMIC STABILITY. IN REGIONS WHERE PROPERTY RIGHTS ARE AMBIGUOUS OR CONTESTED, INDIVIDUALS MAY RESORT TO VIOLENCE OR COERCION TO ASSERT THEIR CLAIMS, LEADING TO SOCIAL UNREST AND HAMPERING ECONOMIC DEVELOPMENT.
