THE PROVISION OF PUBLIC GOODS IS OFTEN A MAJOR FOCUS OF SOCIAL BENEFITS ECONOMICS AS THESE GOODS TYPICALLY REQUIRE GOVERNMENT INTERVENTION TO ENSURE THEY ARE AVAILABLE TO EVERYONE.

EXTERNALITIES

EXTERNALITIES OCCUR WHEN AN ECONOMIC ACTIVITY IMPACTS THIRD PARTIES WHO ARE NOT DIRECTLY INVOLVED IN THE TRANSACTION. THEY CAN BE POSITIVE OR NEGATIVE. FOR INSTANCE, A FACTORY THAT EMITS POLLUTION CREATES A NEGATIVE EXTERNALITY AFFECTING THE HEALTH OF NEARBY RESIDENTS. CONVERSELY, EDUCATION CAN YIELD POSITIVE EXTERNALITIES, SUCH AS A MORE INFORMED AND PRODUCTIVE WORKFORCE. SOCIAL BENEFITS ECONOMICS SEEKS TO ADDRESS EXTERNALITIES THROUGH REGULATIONS AND INCENTIVES THAT ALIGN PRIVATE COSTS OR BENEFITS WITH SOCIAL COSTS OR BENEFITS.

INCOME DISTRIBUTION

INCOME DISTRIBUTION REFERS TO HOW EVENLY OR UNEVENLY INCOME IS DISTRIBUTED ACROSS A POPULATION. INEQUITABLE INCOME DISTRIBUTION CAN LEAD TO SOCIAL UNREST, DECREASED ECONOMIC MOBILITY, AND REDUCED SOCIAL WELFARE. SOCIAL BENEFITS ECONOMICS EXAMINES THE IMPLICATIONS OF INCOME INEQUALITY AND ADVOCATES FOR POLICIES THAT PROMOTE A FAIRER DISTRIBUTION OF RESOURCES, EMPHASIZING THE NEED FOR PROGRESSIVE TAXATION AND SOCIAL SAFETY NETS.

TYPES OF SOCIAL BENEFITS

- IMPROVED PUBLIC INFRASTRUCTURE
- ENVIRONMENTAL SUSTAINABILITY INITIATIVES

- SUPPORT FOR LOCAL BUSINESSES

WHILE THESE BENEFITS MAY NOT BE IMMEDIATELY VISIBLE, THEY CONTRIBUTE SIGNIFICANTLY TO SOCIETAL WELFARE AND ECONOMIC RESILIENCE.

SROI PROVIDES A COMPREHENSIVE VIEW OF THE SOCIAL BENEFITS GENERATED, ALLOWING STAKEHOLDERS TO ASSESS THE TRUE IMPACT OF THEIR INVESTMENTS.
