HISTORICAL CONTEXT OF SUPPLY-SIDE ECONOMICS

THE LAFER CURVE

A KEY CONCEPT WITHIN SUPPLY-SIDE ECONOMICS IS THE LAFER CURVE, WHICH ILLUSTRATES THE RELATIONSHIP BETWEEN TAX RATES AND TAX REVENUE. IT POSITS THAT INCREASING TAX RATES BEYOND A CERTAIN POINT CAN LEAD TO A DECREASE IN
