- **MICROECONOMIC INTERVENTIONS:** WHILE THE BUREAU ANALYZES MICROECONOMIC FACTORS, IT TYPICALLY DOES NOT ENGAGE IN DIRECT INTERVENTIONS WITHIN SPECIFIC MARKETS.

ADDITIONALLY, THE GENERAL PUBLIC GAINS FROM INCREASED TRANSPARENCY AND UNDERSTANDING OF ECONOMIC CONDITIONS, WHICH CAN ENHANCE TRUST IN ECONOMIC INSTITUTIONS.
