EXTRACURRICULAR ACTIVITIES

EXTRACURRICULAR INVOLVEMENT, PARTICULARLY IN ACTIVITIES RELATED TO ECONOMICS, BUSINESS, OR LEADERSHIP, CAN FURTHER BOLSTER AN APPLICATION. DEMONSTRATING A COMMITMENT TO COMMUNITY SERVICE OR PARTICIPATION IN RELEVANT CLUBS CAN ALSO SHOWCASE WELL-ROUNDEDNESS AND DEDICATION.

APPLICATION PROCESS FOR UC BERKELEY ECONOMICS

THE APPLICATION PROCESS FOR UC BERKELEY'S ECONOMICS PROGRAM IS STRAIGHTFORWARD BUT REQUIRES CAREFUL ATTENTION TO DETAIL. HERE ARE THE KEY STEPS INVOLVED:

5. **APPLICATION FEE:** A NON-REFUNDABLE APPLICATION FEE MUST BE PAID, THOUGH FEE WAIVERS ARE AVAILABLE FOR ELIGIBLE STUDENTS.

TIPS FOR A STRONG APPLICATION

- **PREPARE FOR INTERVIEWS:** IF AN INTERVIEW IS PART OF THE PROCESS, PRACTICE COMMON QUESTIONS AND ARTICULATE YOUR GOALS CLEARLY.
- **STAY ORGANIZED:** KEEP TRACK OF DEADLINES AND REQUIRED MATERIALS TO ENSURE A COMPLETE APPLICATION.
