UNDERSTANDING GPI

GENUINE PROGRESS INDICATOR (GPI) IS AN ECONOMIC METRIC DESIGNED TO PROVIDE A MORE HOLISTIC VIEW OF A COUNTRY'S PROGRESS. HISTORICAL BACKGROUND OF GPI
