HISTORICAL DEVELOPMENT OF ECONOMIC THOUGHT

THE ART OF ECONOMICS HAS A RICH HISTORY THAT TRACES BACK TO ANCIENT CIVILIZATIONS. THE EVOLUTION OF ECONOMIC THOUGHT REFLECTS CHANGING SOCIETAL VALUES AND CONTEXTS.
