

BOUNDED MATH DEFINITION

IF A FUNCTION IS BOTH BOUNDED ABOVE AND BOUNDED BELOW, IT IS SIMPLY REFERRED TO AS A BOUNDED FUNCTION.

UNDERSTANDING BOUNDEDNESS IS CRUCIAL FOR VARIOUS MATHEMATICAL ANALYSES, AS IT ALLOWS MATHEMATICIANS AND SCIENTISTS TO PREDICT THE BEHAVIOR OF FUNCTIONS AND SETS UNDER DIFFERENT CONDITIONS.

TYPES OF BOUNDED FUNCTIONS

3. **QUADRATIC FUNCTION:** THE FUNCTION $f(x) = -x^2 + 4$ HAS A MAXIMUM VALUE OF 4 (BOUNDED ABOVE) AND APPROACHES NEGATIVE INFINITY AS x MOVES AWAY FROM 0. THUS, IT IS NOT BOUNDED BELOW.

THESE EXAMPLES ILLUSTRATE HOW VARIOUS FUNCTIONS CAN EXHIBIT BOUNDEDNESS DEPENDING ON THEIR MATHEMATICAL PROPERTIES. THEY ALSO HIGHLIGHT THE IMPORTANCE OF IDENTIFYING BOUNDARIES WHEN ANALYZING FUNCTIONS.
