UNDERSTANDING THE ROLE OF MATHEMATICS IN MACROECONOMICS

- **MATHEMATICS IS ONLY FOR QUANTITATIVE ECONOMISTS:** EVEN QUALITATIVE ECONOMISTS BENEFIT FROM UNDERSTANDING THE BASIC MATHEMATICS OF THEIR FIELD.

RECOGNIZING THESE MISCONCEPTIONS CAN HELP STUDENTS APPROACH MACROECONOMICS WITH CONFIDENCE. IT IS ESSENTIAL TO UNDERSTAND THAT WHILE MATH IS A SIGNIFICANT COMPONENT, IT IS NOT THE SOLE FOCUS OF THE DISCIPLINE.
