Quadrant Bearings (or Surveyor's Bearings)

This system uses the North-South line as the reference and indicates the angle eastward or westward from that line. For example, a bearing of N30°E means 30 degrees east of North. A bearing of S45°W means 45 degrees west of South. These bearings are always between 0° and 90°. This is the most common notation encountered in many practical applications.

The format for a quadrant bearing typically looks like this: Cardinal Direction (N or S) + Angle (degrees) + Cardinal Direction (E or W).

- **N60°E**: This indicates a direction that is 60 degrees east of North.
- **S20°W**: This means 20 degrees west of South.
- **N85°W**: This points 85 degrees west of North.
- **S10°E**: This indicates a direction 10 degrees east of South.

Azimuth Bearings

Azimuth bearings are measured clockwise from true north and range from 0° to 360°. An azimuth of 0° is North, 90° is East, 180° is South, and 270° is West. This system is often used in military contexts, astronomy, and some surveying applications because it provides a single, continuous angle and avoids the need for N/S and E/W notations. It's a more direct angular measurement.

Here's how to convert between azimuth and quadrant bearings:

- If an azimuth is between 0° and 90°, the quadrant bearing is N(azimuth)°E.
- If an azimuth is between 90° and 180°, the quadrant bearing is S(180° - azimuth)°E.
- If an azimuth is between 180° and 270°, the quadrant bearing is S(azimuth - 180°)°W.
- If an azimuth is between 270° and 360°, the quadrant bearing is N(360° - azimuth)°W.

How to Calculate Bearings

Calculating bearings often involves trigonometry, especially when you're given the coordinates of two points or distances and angles in a triangle. The core principle is to determine the angle of elevation or depression from a reference line, typically North.

Using Coordinates

If you have the coordinates of two points, say Point A (x_1, y_1) and Point B (x_2, y_2), you can calculate the bearing from A to B. First, find the difference in the x and y coordinates: $\Delta x = x_2 - x_1$ and $\Delta y = y_2 - y_1$. The angle can be found using the arctangent function ($\tan^{-1}$). The general formula for the angle θ from the positive x-axis is $\theta = \tan^{-1}(\Delta y / \Delta x)$. So, if Δy is North and Δx is East:

- If $\Delta x > 0$ and $\Delta y < 0$ (Quadrant 4: South-East), Bearing = $90^\circ + \arctan(\Delta x / |\Delta y|)$.
- If $\Delta x < 0$ and $\Delta y < 0$ (Quadrant 3: South-West), Bearing = $180^\circ + \arctan(|\Delta x| / |\Delta y|)$.
- If $\Delta x < 0$ and $\Delta y > 0$ (Quadrant 2: North-West), Bearing = $270^\circ + \arctan(|\Delta x| / \Delta y)$.

Remember to adjust these formulas based on whether you are using quadrant bearings or azimuths, and the specific orientation of your coordinate system.

Using Trigonometric Principles (SOH CAH TOA)

When you have a right-angled triangle formed by distances and directions, you can use the basic trigonometric ratios: sine, cosine, and tangent. For instance, if you know the distance traveled East (opposite to the North direction) and the distance traveled North (adjacent to the North direction), you can use the tangent function. If you know the hypotenuse (direct distance) and one other side, you can use sine or cosine.

Let's say you have a right-angled triangle where the North direction is one side, the East direction is another, and the hypotenuse is the direct path.

If you want to find the bearing from North:

- **Cosine:** If you know the distance North (adjacent) and the direct distance (hypotenuse), $\text{Bearing} = \cos^{-1}(\text{Distance North} / \text{Direct Distance})$. This gives you the angle from the North line towards East.

These calculations typically result in an angle between 0° and 90° . You then need to combine this angle with the correct cardinal directions (N/S and E/W) to form the quadrant bearing, or use it to directly calculate an azimuth.

Working with Bearings in Navigation Problems
